

# HER LITERARY TRAVEL

**TERMS & CONDITIONS:** These Terms and Conditions (“Agreement”) govern all registrations for Prince Edward Island tours offered by Her Literary Travel, a division of Her Literary Society (“we,” “us,” “our”). By submitting your tour registration and deposit, you (“Participant,” “you,” “your”) acknowledge that you have read, understood, and agree to be bound by the following:

## 1. Registration and Payment Schedule

**Eligibility:** Her Literary Travel tours are exclusively for women ages 18 and older. By registering, you confirm that you meet this requirement.

Your reservation is not confirmed until the deposit has been received. By registering, you agree to the following payment schedule:

Single Room:

- **Due upon registration:** \$750 non-refundable deposit
- **April 1, 2026:** \$1166
- **June 1, 2026:** \$1166
- **August 1, 2026:** \$1166

Double Room:

- **Due upon registration:** \$750 non-refundable deposit
- **April 1, 2026:** \$900
- **June 1, 2026:** \$900
- **August 1, 2026:** \$900

A 2.5% transaction fee applies to all payments made by credit or debit card.

## 2. Participant Cancellation

Cancellations must be submitted in writing. The following fees apply based on the date your cancellation is received:

- **90 days or more before departure:** 20% of tour price
- **89–57 days before departure:** 30%
- **56–43 days before departure:** 50%
- **42–29 days before departure:** 60%
- **28–15 days before departure:** 90%
- **14 days or less before departure:** 100%

No refunds are issued for unused portions of the tour.

---

## 3. Cancellations or Changes by Her Literary Travel

We reserve the right to:

- Cancel a tour due to unforeseen circumstances or events outside our control.
- Make adjustments to the itinerary, accommodations, schedule, or included activities as needed for the comfort and safety of the group.

In the event of a full tour cancellation by us:

- Participants will receive a refund of all payments made to Her Literary Travel.
- This refund does not include any personal expenses incurred outside the tour (airfare, travel insurance, etc.).

We are not responsible for additional costs incurred due to travel delays, airline changes, border closures, or acts of nature.

## 4. Travel Insurance

Comprehensive travel insurance—including trip cancellation, medical coverage, emergency evacuation, and baggage protection—is strongly recommended. Participants who choose not to purchase insurance assume all associated risk.

## 5. Health and Tour Readiness

By registering, you confirm that:

- You are in suitable physical condition to participate in all included activities.
- You can comfortably walk a minimum of 2 miles.
- You do not have any medical conditions that would create a risk to yourself or others.

Participants are responsible for assessing whether the tour is appropriate for their abilities. Her Literary Travel may decline participation if a guest's health or safety could be compromised.

## 6. Participant Responsibilities

Participants agree to:

- Follow all instructions from tour leaders and guides
  - Arrive on time for all scheduled departures. The group cannot delay for late participants.
  - Manage their own personal belongings. Her Literary Travel is not responsible for lost, stolen, or damaged items.

## 7. Accommodations and Rooming

Room types are subject to availability at the time of registration. Any accommodation changes requested during the tour are at the participant's expense.

## 8. Photography and Media Release

By joining the tour, you grant permission for photographs and video taken during the trip to be used by Her Literary Travel for promotional, editorial, and marketing purposes.

If you prefer not to be photographed, you must notify us in writing before departure.

## 9. Personal Travel Arrangements

Participants are responsible for:

- Booking their own airfare
- Ensuring all travel documents (passport, visas, etc.) are valid
- Managing the risks of airline delays, weather events, or missed connections

Such disruptions do not alter the terms of this Agreement.

## 10. Governing Law

This Agreement is governed by the laws of the State of California.

By submitting your registration and deposit, you affirm that:

- You have read and agree to these Terms and Conditions
- You understand the payment schedule and cancellation policy
- You confirm that you can comfortably walk 2 miles and are physically prepared for the tour
